

# ONLINE PRIVACY POLICY AGREEMENT

Pendulo Key Sports Bar (Pendulo Key Sports Bar) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Pendulo Key Sports Bar of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy mandates.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time Pendulo Key Sports Bar decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether to permit the use of their information in this separate matter.

Pendulo Key Sports Bar may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. - as necessary to maintain, safeguard and preserve all the rights and property of Pendulo Key Sports Bar.

## Notice to European Union Users

Pendulo Key Sports Bar's operations are located primarily in the United States. ## Security

Pendulo Key Sports Bar takes precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline. The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information. In addition, Pendulo Key Sports Bar is a licensee of TRUSTe. The website is also secured by VeriSign.
